

Manuscript Withdrawal Policy

We understand that authors may sometimes need to withdraw a manuscript after submission. However, manuscript withdrawal should be done responsibly and only under legitimate circumstances, as withdrawing a paper after it has entered the peer review or publication process can cause delays and disruptions.

Legitimate Reasons for Withdrawal

1. **Significant Errors:** The manuscript contains major errors that were discovered after submission, and correcting these errors would require a substantial rewrite.
2. **Duplicate Submission:** The manuscript has been submitted to another journal simultaneously, which violates submission guidelines. In such cases, the manuscript must be withdrawn from one journal immediately.
3. **Ethical Concerns:** Issues such as conflicts of interest, plagiarism, or other ethical concerns that may affect the integrity of the research.
4. **Author's Request:** Authors may request withdrawal for personal reasons, such as changes in research focus or funding availability, provided the request is made at an early stage.

Withdrawal Process

1. **Before Review:** If authors wish to withdraw a manuscript before it enters the peer review process, they must notify the editorial office as soon as possible. Manuscripts withdrawn at this stage face no penalties.
2. **During Peer Review:** If the manuscript is under peer review, authors must provide a written explanation and formal request for withdrawal. Withdrawal at this stage may be accepted under reasonable circumstances but is subject to editorial approval. Failure to provide a legitimate reason may result in sanctions.
3. **After Acceptance:** Manuscript withdrawal after acceptance is strongly discouraged. If withdrawal is requested at this stage, it will only be granted under exceptional circumstances, as significant resources have already been invested in the publication process. If granted, penalties may be imposed, including a ban on future submissions to MAT Journals.
4. **Post-Publication:** If authors request withdrawal after publication due to errors or ethical issues, the journal will follow retraction guidelines as per COPE standards, and the paper may be retracted from the journal's database.

Consequences of Unjustified Withdrawal

1. **Unjustified or repeated withdrawals** can lead to sanctions against the author(s), including but not limited to:
 - **Submission Ban:** A temporary or permanent ban on future submissions to MAT Journals.
 - **Notification of Institutions:** If misconduct is suspected, the author's institution or funding bodies may be informed.
2. **Misleading Withdrawals:** Authors withdrawing a manuscript to submit to another journal without disclosing this intention or due to unfavorable peer reviews will be considered unethical and subject to penalties.
